Letter to the editor

Baring Square Church and County Building

I take exception to Ashburton District Council's Paul Brake saying in his recent Press Release that "Heritage New Zealand do not recognise any heritage or cultural value in the buildings". He was talking about the Baring Square Methodist Church and former County Council buildings.

Has Mr Brake actually asked Heritage New Zealand?

I believe he has carefully worded this out of context. Heritage New Zealand would never say that these buildings have no heritage or cultural value. The heritage, social and culture value in these buildings is huge. If people that work at council are unable to see this, then we in Ashburton have a serious problem!

If he had said that neither building appeared on Heritage New Zealand's listing, he would be right. They don't, as many of our heritage buildings don't. If he had said they failed to appear on the ADC heritage schedule he would also be right, they don't. In July 2009 I and others from our group worked with consultants Boffa Miskell, NZHPT and council to revise the heritage section of the district plan. By the time we realised we had completely missed the Baring Square Church the schedule had already gone out for consultation. As for the Country Council Building, my notes from the time tell me our group members ticked it to be added. But at this time it was being considered by ADC as a sale to the Licencing Trust who planned to make it a boutique hotel! Perhaps this was why it never made it to the list!

Also I ask, why is Ashburton District Council defending the Your Council, Your Library, Your Voice discussion paper produced by its consultants Opus? After all was it not created to stimulate public debate and gather opinion?

My last point is that the Your Council, Your Library, Your Voice discussion paper is very heavy reading for the average person to digest. If feel it is a shame our organisation, and others, have had to point out the consequences of some options. This included the use of our own limited funds for paid advertisements to do so!

Please, don't just think about filling in the feedback form – do it! They close next Monday September 18th.
